42apps LLC ("us", "we", or "our") operates the Day Flow mobile application.

This Privacy Policy describes how **Day Flow** (hereinafter referred to as "we", "us", or "our") collects, uses, shares, and protects user information obtained through the Day Flow mobile application (the "App"). By using our App, you understand and agree to the collection, storage, processing, and use of your data in accordance with this Privacy Policy.

1. Information We Collect

We may collect the following types of information:

1.1 Personal Information

This refers to the data that you voluntarily provide to us, which identifies you personally. This includes, but is not limited to, your name and email address; it may also include other personal and preference information you provide to us.

1.2 Non-Personal Information

We may also collect data in a form that does not, on its own, permit direct association with any specific individual. We may collect, use, transfer, and disclose non-personal information for any purpose. This information includes, but is not limited to, task name, task date and time, category etc.

1.3 Information from Third Parties

We may receive information about you from third-party analytics providers, such as Amplitude, Firebase, Appsflyer, Facebook SDK, and Apphud. This information may include usage details, geographic location, and demographic information.

2. Use of Collected Information

We use the information we collect to provide, maintain, protect, and improve our App, to develop new services, and to protect us and our users.

2.1 Apple Calendar Access and Push Notifications

With your consent, we may access your Apple Calendar to assist you in managing your tasks and schedules. We may also send you push notifications related to your tasks and schedules.

2.2 GPT API

We use the OpenAI GPT API to provide smart assistant capabilities within the App. This means that the tasks, queries, and instructions you input into the App may be processed by the GPT API to provide you with appropriate responses.

2.3 iCloud Sync

Your data may be synced across your devices using iCloud. You may choose to deactivate this feature, but please note that doing so may affect your user experience and the functionality of the App.

3. Information Sharing and Disclosure

We do not sell your personal information to third parties. However, we may share your personal information with third parties as described in this policy.

3.1 Service Providers and Business Partners

We may use third-party companies and individuals to facilitate our service (e.g., maintenance services, database management, web analytics, and payment processing), or to assist us in analyzing how our service is used. These third parties may have access to your Personal Information but only to perform these tasks on our behalf.

4. Security

We are committed to ensuring that your information is secure. We have implemented measures and procedures to prevent unauthorized access, use, alteration, and disclosure of your information. Despite these measures, the Internet is not a fully secure environment and we cannot guarantee that your personal information will not be disclosed, destroyed, altered, or accessed in an unauthorized manner.

5. Children's Privacy

Our App is not intended for use by children under the age of 13. We do not knowingly collect personal information from children under 13. If we discover that a child under 13 has provided us with personal information, we will delete such information from our servers immediately.

We may update our Privacy Policy from time to time. We will notify you of any changes by posting the new Privacy Policy on this page. You are advised to review this Privacy Policy periodically for any changes.
